Dear Parent or Guardian,

I hope that this communication finds everyone safe, healthy and well. The Monroe County Community School Corporation (MCCSC) received notification that we will be able to provide **FREE MEALS** (Breakfast and Lunch) to **ALL ENROLLED MCCSC STUDENTS** beginning Wednesday, September 16th and we hope to run the program through December 31, 2020 (subject to available funding). The temporary funding source we are accessing is a new waiver that was recently approved for the Summer Food Service Program, operated under the USDA.

So what does this mean.....

- Breakfast and Lunch will operate as they have in the past
  - MCCSC E-Learners and Hybrid Learners can participate in the program
- No action is required of families to participate in this free meal program.
- Students will still use their meal accounts so we can track who is eating and avoid any allergy issues.
  - Students will be charged for seconds, a la carte items and/or extra milk.
- All money that is currently in meal accounts will remain in those accounts to be used for student meals after December 31, 2020.

Even though all students will receive free meals at this time, we still recommend all families that are eligible – if they have not already done so – to complete an application for Free & Reduced Meal and text book Program assistance so you are eligible for that program when this current opportunity ends. Families that do not have an approved application on file will receive a bill for curricular supplies.

We are excited to bring this program to MCCSC families to help provide financial relief during this extraordinary time. Feel free to contact us with any questions you may have.
